### 2.1 HANDLING OF DATA

### 2.3 COOKIES AND GOOGLE ANALYTICS

When our website is called up, a small file, a so-called "cookie", is stored in the memory of the user's computer. This tracking technology is primarily used to precisely record the number of visitors. The information that Hospitalityfriends GmbH receives and stores via "cookies" during normal visits to its websites is used exclusively within Hospitalityfriends GmbH or its affiliated companies to optimize the websites and the user experience. This website also uses Google Analytics, a web analysis service of Google Inc. (hereafter Google).
